NEGATIVE REVENUE IS DUE TO THE COSTS OF THE CENTER'S 2021 BOOK, "THE RAILROAD AND THE ART OF PLACE: AN ANTHOLOGY," EXCEEDING ITS SALES REVENUE. NOT SHOWN HERE IS THAT THE CENTER RECEIVED GRANT FUNDING TOTALLING \$51,000 FROM THE KAHLER FAMILY CHARITABLE FUND (THE KAHLER GRANT) TO COVER THE ENTIRE PRODUCTION COSTS OF THIS BOOK, SO ALL PROCEEDS FROM THIS BOOK SUPPORT THE CENTER'S MISSION AND PROGRAMS. OTHER BOOKS, TYPICALLY PUBLISHED ANNUALLY AND WITHOUT GRANT FUNDING, CONTINUE TO GENERATE POSITIVE REVENUE. THE FINE-ART APPROACH OF "THE RAILROAD AND THE ART OF PLACE: AN ANTHOLOGY" IS HELPING INTRODUCE THE CENTER'S WORK TO NEW AUDIENCES AND MARKETS. THE CENTER PUBLISHES A QUARTERLY JOURNAL, "RAILROAD HERITAGE," THAT USES PHOTOGRAPHS AND ART

THE CENTER MAINTAINS AN ARCHIVE OF APPROXIMATELY 490,000 PHOTOGRAPHS AND PERFORMS ARCHIVAL PROCESSING OF ITS COLLECTION INTO ARCHIVAL-SAFE STORAGE MATERIALS. ANTICIPATED ADDITIONS IN 2022 AND BEYOND SHOULD PUSH THE TOTAL NUMBER OF IMAGES ABOVE 900,000. THE CENTER DIGITIZES BOTH THE PHOTOGRAPHS AND THEIR ASSOCIATED METADATA, SHARING IMAGES THROUGH ITS WEBSITE, SOCIAL MEDIA CHANNELS, AND PUBLICATIONS, WHILE MAKING THE IMAGES AVAILABLE TO RESEARCHERS, AUTHORS, AND OTHER USERS. GROWTH OF THE COLLECTION HAS LED TO A SUBSTANTIAL INCREASE IN IMAGE USAGE REQUESTS, AND IMAGES FROM THE CENTER'S ARCHIVE NOW APPEAR FREQUENTLY IN BOOKS AND MAGAZINES BY OTHER PUBLISHERS AND AUTHORS. ONE EXAMPLE IS THE "ARCHIVES TREASURES" FEATURE THAT APPEARS IN EACH ISSUE OF CLASSIC

IN TYPICAL YEARS THE CENTER HOSTS ONE OR TWO ANNUAL CONFERENCES, ONE NATIONAL EVENT NEAR CHICAGO AND SOMETIMES ANOTHER REGIONAL CONFERENCE IN A DIFFERENT CITY FEATURING PRESENTATIONS ABOUT RAILROAD PHOTOGRAPHY AND ART. THE EVENTS GIVE PHOTOGRAPHERS AND RESEARCHERS THE OPPORTUNITY TO NETWORK AND EXCHANGE IDEAS, BOTH THROUGH FORMAL PROGRAMMING AND SOCIAL ACTIVITIES. ATTENDEES COME FROM ALL OVER THE UNITED STATES AND SEVERAL OTHER COUNTRIES. DUE TO THE COVID-19 PANDEMIC, THE CENTER NIMBLY SHIFTED TO ONLINE EVENTS WITH GREAT SUCCESS, HOSTING A FULL-DAY ONLINE CONFERENCE IN APRIL AND A HALF-DAY CONFERENCE IN NOVEMBER, AUGMENTED BY WEEKNIGHT EVENTS IN EVERY OTHER MONTH. PARTICIPANTS CAME FROM ALL OVER THE COUNTRY AND WORLD, WITH ATTENDANCE RANGING FROM 100

THE CENTER ALSO PUT THREE OF ITS TRAVELING EXHIBITIONS ONLINE USING THE KUNSTMATRIX PLATFORM TO ALLOW MORE VIEWERS TO SEE THESE SHOWS. AS COVID RESTRICTIONS EASE, THE CENTER IS WORKING WITH ADDITIONAL PARTNER VENUES TO GET MORE EXHIBITIONS BACK ON THE ROAD IN 2022 AND BEYOND, INCLUDING A CURRENT SHOWING OF "RAILROADERS AT THE HISTORIC PULLMAN FOUNDATION" IN PULLMAN, ILLINOIS. MEANWHILE, CENTER STAFF MEMBERS ARE DEVELOPING A NEW TRAVELING EXHIBITION PROGRAM BASED ON RAIL TRAILS INCLUDING THEIR HISTORY AS RAILROADS AND CURRENT PUBLIC ENGAGEMENT OPPORTUNITIES.
