THE CENTER MAINTAINS AN ARCHIVE OF MORE THAN 500,000 PHOTOGRAPHS, PAINTINGS, DRAWINGS, AND PRINTS; ITS STAFF MEMBERS PERFORM ARCHIVAL PROCESSING OF THIS COLLECTION INTO ARCHIVAL-SAFE STORAGE MATERIALS. ANTICIPATED ADDITIONS IN 2024 AND BEYOND WILL PUSH THE TOTAL NUMBER OF IMAGES ABOVE 1,000,000. THE CENTER DIGITIZES MANY OF THE IMAGES AS WELL AS THEIR ASSOCIATED METADATA, SHARING THEM THROUGH ITS WEBSITE, SOCIAL MEDIA CHANNELS, AND PUBLICATIONS, WHILE MAKING THEM AVAILABLE TO RESEARCHERS, AUTHORS, AND OTHER USERS. GROWTH OF THE COLLECTION HAS LED TO A SUBSTANTIAL INCREASE IN IMAGE USAGE REQUESTS, AND IMAGES FROM THE CENTER'S ARCHIVE NOW APPEAR FREQUENTLY IN BOOKS AND MAGAZINES BY OTHER PUBLISHERS AND AUTHORS. THE CENTER HOSTS AN ANNUAL CONFERENCE NEAR CHICAGO AND SOMETIMES ANOTHER REGIONAL CONFERENCE IN A DIFFERENT CITY FEATURING PRESENTATIONS ABOUT RAILROAD PHOTOGRAPHY AND ART. THE EVENTS GIVE PHOTOGRAPHERS AND RESEARCHERS THE OPPORTUNITY TO NETWORK AND EXCHANGE IDEAS THROUGH PROGRAMMING AND SOCIAL ACTIVITIES. ATTENDEES COME FROM ALL OVER THE UNITED STATES AND SEVERAL OTHER COUNTRIES. THE 2023 CONFERENCE SOLD OUT WITH 170 ATTENDEES IN LESS THAN TWO MONTHS; A MOVE TO A LARGER AUDITORIUM FOR THE 2024 CONFERENCE EXPANDED CAPACITY TO 192 ATTENDEES WHICH ALSO SOLD OUT IN TWO MONTHS.
