THE CENTER MAINTAINS AN ARCHIVE OF MORE THAN 600,000 PHOTOGRAPHS, PAINTINGS, DRAWINGS, AND PRINTS; ITS STAFF MEMBERS PERFORM ARCHIVAL PROCESSING OF THIS COLLECTION INTO ARCHIVAL-SAFE STORAGE MATERIALS. ANTICIPATED ADDITIONS IN 2025 AND BEYOND WILL PUSH THE TOTAL NUMBER OF IMAGES CLOSE TO 1,100,000. THE CENTER DIGITIZES MANY OF THE IMAGES AS WELL AS THEIR ASSOCIATED METADATA, SHARING THEM THROUGH ITS WEBSITE, SOCIAL MEDIA CHANNELS, AND PUBLICATIONS, WHILE MAKING THEM AVAILABLE TO RESEARCHERS, AUTHORS, AND OTHER USERS. GROWTH OF THE COLLECTION HAS LED TO A SUBSTANTIAL INCREASE IN IMAGE USAGE REQUESTS, AND IMAGES FROM THE CENTER'S ARCHIVE NOW APPEAR FREQUENTLY IN BOOKS AND MAGAZINES BY OTHER PUBLISHERS AND AUTHORS. ONE EXAMPLE IS THE "ARCHIVES TREASURE" FEATURE

BOOKS ADD TO THIS MESSAGE, AND THE CENTER CONTINUES TO PUBLISH ONE EACH YEAR. THE TITLE FOR 2024 IS BURLINGTON'S SPECTACULAR STEAM PROGRAM. THE EVENTS GIVE PHOTOGRAPHERS AND RESEARCHERS THE OPPORTUNITY TO NETWORK AND EXCHANGE IDEAS THROUGH PROGRAMMING AND SOCIAL ACTIVITIES. ATTENDEES COME FROM ALL OVER THE UNITED STATES AND SEVERAL OTHER COUNTRIES. THE 2023 CONFERENCE SOLD OUT WITH 170 ATTENDEES IN LESS THAN TWO MONTHS; A MOVE TO A LARGER AUDITORIUM FOR THE 2024 CONFERENCE EXPANDED CAPACITY TO 192 AND THE EVENT WAS SOLD OUT. THE CENTER HOSTED ITS FIRST ONLINE PROGRAM IN 2020 AND NOW MANAGES A MONTHLY SERIES OF ONLINE PRESENTATIONS THAT APPEAR LIVE VIA ZOOM AND ARE THEN RECORDED AND POSTED TO YOUTUBE FOR LATER
